

**Forest Lake Shopping Centre (Centre)**

**Terms and Conditions**

**Participation in the Competition**

1. By participating in the Competition, the Participant agrees to these Terms and Conditions.
2. To participate in the Competition, the Participant must be an Eligible Person who makes an Eligible Entry during the Competition Period.
3. Eligible Persons may enter the Competition only once during the Competition Period.
4. To enter the Competition, the Eligible Person must during the Competition Period:
  - (a) register for, and complete:
    - a. a mall walk with the Heart Foundation Walking Group at the Centre on the 2<sup>nd</sup>, 4<sup>th</sup>, 7<sup>th</sup>, 9<sup>th</sup>, 11<sup>th</sup>, 14<sup>th</sup>, 16<sup>th</sup>, 18<sup>th</sup>, 21<sup>st</sup>, 23<sup>rd</sup>, 25<sup>th</sup>, 28<sup>th</sup>, or 30<sup>th</sup> of May ; or
    - b. a 5 kilometre walk/run with Forest Lake Park Run on the 5<sup>th</sup>, 12<sup>th</sup>, 19<sup>th</sup> or 26<sup>th</sup> of May; and
  - (b) if the Eligible Person is under the age of 18 years, be consented to by a parent or guardian of the Eligible Person and any relevant consent form signed where applicable.

**The Competition**

5. The Competition will be conducted at the Centre and at Forest Lake Sports Fields, 310 Forest Lake Boulevard, Forest Lake during the Competition Period. The Competition will end on expiration of the Competition Period.

**Eligibility**

6. The Competition is only open to Eligible Persons.
7. The Promoter reserves the right, at any time, to verify the eligibility of any Participant (including a Participant's identity, age and place of residence) and to disqualify any Participant who does not comply strictly with these Terms and Conditions or who tampers with the entry process. Incomplete, indecipherable or illegible entries will be deemed invalid. If requested by the Promoter, a Participant must provide the Promoter with evidence of eligibility. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

**The Prize**

8. There will be one (1) Prize and one (1) winner of a Prize (**Prize Winner**).
9. The Prize is not transferable, refundable or exchangeable and cannot be taken as cash.
10. The first Eligible Entry drawn at random will win the Prize.
11. The draw will take place at 10:00am on 3 June 2018 at Centre Management Office.
12. If the Prize Winner is under the age of 18 years, the parent or guardian of the Prize Winner who gave permission for entry into the Competition will be deemed to be the Prize Winner for the purposes of the Competition.

13. The Promoter will use reasonable efforts to notify the Prize Winner by mail, telephone, or email to arrange delivery or collection of the Prize.
14. If despite reasonable efforts the Promoter is unable to locate or contact the Prize Winner within one (1) month after the winner is decided, another Prize Winner will be drawn at 10:00am on 3 July 2018 at the Centre's Centre Management Office. Any subsequent winner will be notified in accordance with these Terms and Conditions.
15. The Promoter may, but is not obliged to, publish the results of the Competition. By participating in the Competition, the Participant gives their consent for their personal details to be published in the manner prescribed in this clause if they are the recipient of a Prize. If the Promoter decides to publish the results of the Competition, then the Promoter will publish the results on the Centre's Facebook page.
16. A Participant claiming to be the Prize Winner will be required to provide proof of identity.
17. The Prize is subject to the conditions relating to the use of the Prize (including validity period) which can be viewed on the Prize itself.

**Other General Terms**

18. All Competition entries are the property of the Promoter.
19. The Promoter Entities, Heart Foundation Walking Group and Forest Lake Park Run Group shall not be liable (including, without limitation, in negligence) for:
  - (a) any loss or damage whatsoever that is suffered (including, but not limited to, indirect or consequential loss); or
  - (b) any personal injury suffered or sustained, during the course of participating in this Competition or using the Prize, except for and to the extent that any liability cannot be excluded by law.
20. Each Participant indemnifies and keeps indemnified the Promoter Entities, Heart Foundation Walking Group and Forest Lake Park Run Group against all claims, losses, damages, costs and expenses suffered or incurred by the Promoter Entities or any third parties arising out of the breach of these Terms and Conditions by the Participant, the conduct of the Participant in the Competition or the use of the Prize by the Participant.
21. If this Competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law and subject to any written directions from a regulatory authority (if any) to:
  - (a) disqualify any Participant; and/or
  - (b) modify, suspend, terminate or cancel the Competition as appropriate.

**Privacy**

22. Under the *Privacy Act 1998* (Cth), the Promoter must notify Participants of certain matters when it collects personal information about them including how it plans to use or disclose it. If a Participant chooses to enter or take part in the Competition, the Participant will be

required to provide the Promoter with personal information about themselves such as the Participant's full name, address, telephone number, email address and Heart Foundation Walking Group or Forest Lake Park Run Group registration of activities during the Competition Period.

23. The Promoter will collect, use and disclose the personal information which the Participant has provided for the carrying out the Competition (including as described in clause 15 in particular and in general for notification and promotion of Prizes).
24. By entering the Competition, the Participant consents to the collection, use and disclosure of his or her personal information in the manner outlined in these Terms and Conditions.
25. If a Participant would prefer that the Promoter does not use or disclose the Participant's personal information in the way outlined in these Terms and Conditions and/or retain their personal information for the purposes described herein, the Participant should contact the Promoter on 07 3278 8999.
26. A Participant has the right to access, in most circumstances, personal information which the Promoter holds about the Participant. A Participant may contact the Promoter on 07 3278 8999 to ask for access to the Participant's personal information, or if the Participant has a complaint concerning a Participant's information privacy. The Promoter may deny the participant's request for access in some circumstances. If the Promoter does this, it will tell the Participant why.
27. The Promoter's Privacy Policy contains further information on its processes in relation to access to and correction of personal information, about how a Participant may complain about a breach of the Australian Privacy Principles and how the Promoter will deal with such a complaint. 28. If a Participant considers that any personal information that the Promoter holds about the Participant is inaccurate or if at any time the Participant's details change, the Participant may contact the Promoter on 07 3278 8999 and the Promoter will take reasonable steps to ensure that such personal information is corrected. The Promoter will take reasonable steps to keep personal information secure from misuse, interference, loss or unauthorised access, modification or disclosure.

**Definitions**

**"Centre"** means Forest Lake Shopping Centre located at 235 Forest Lake Boulevard, Forest Lake Qld 4078.

**"Competition"** means the opportunity to go into the draw to win the Prize in accordance with these Terms and Conditions.

**"Competition Period"** means the period from 8:30am on 1 May 2018 until 5:00pm on 31 May 2018.

**"Eligible Entry"** means an entry which complies with the requirements of clause 4.

**"Eligible Person"** means an individual who:

- (a) is a resident of Queensland;

- (b) if under 18 years of age, has a parent or guardian's permission to participate in the Competition/Promotion;
- (c) is not a Non Eligible Person; and
- (d) submits an Eligible Entry.

**"Non-Eligible Person"** means the following:

- (a) owners and managers of the Centre;
- (b) retailers of the Centre;

- (d) the employees or contractors of the persons and entities in paragraphs (a) – (c); and
- (e) any spouse, child, de facto or any other person living at the same premises as any of the persons mentioned in paragraphs (a) – (d).
